Item 6: 2022 Membership Dues

"Member congregations are obligated to pay the annual membership fee determined by the members or their Delegates at the Annual Meeting of the LLC" (LLC Bylaws, Article II, Section 1). The dues obligation is a congregation obligation, and congregations use a variety of methods to collect funds from their individual members.

Locally established dues guidelines cover both the LLC dues and the needs of the local congregation. It is a common practice to set a minimum dues level to be a congregation voting member, along with a recommended dues level to cover both local and LLC commitments.

The LLC established practice is that the local congregations pay LLC dues based on the number of voting members reported at their local congregation annual meeting. It is much appreciated that some congregations have even been able to pay LLC dues based on the number of adults, 18 years and over, regardless of local congregation membership.

Current Dues: • \$34 (USD) per member per month, \$408 per member per year • Student: 50% of the above membership dues

LLC Board recommendation: The Board recommends no dues increase for 2022.

The current dues rate was approved by the July 4, 2020, Annual Meeting and became effective January 1, 2021.
